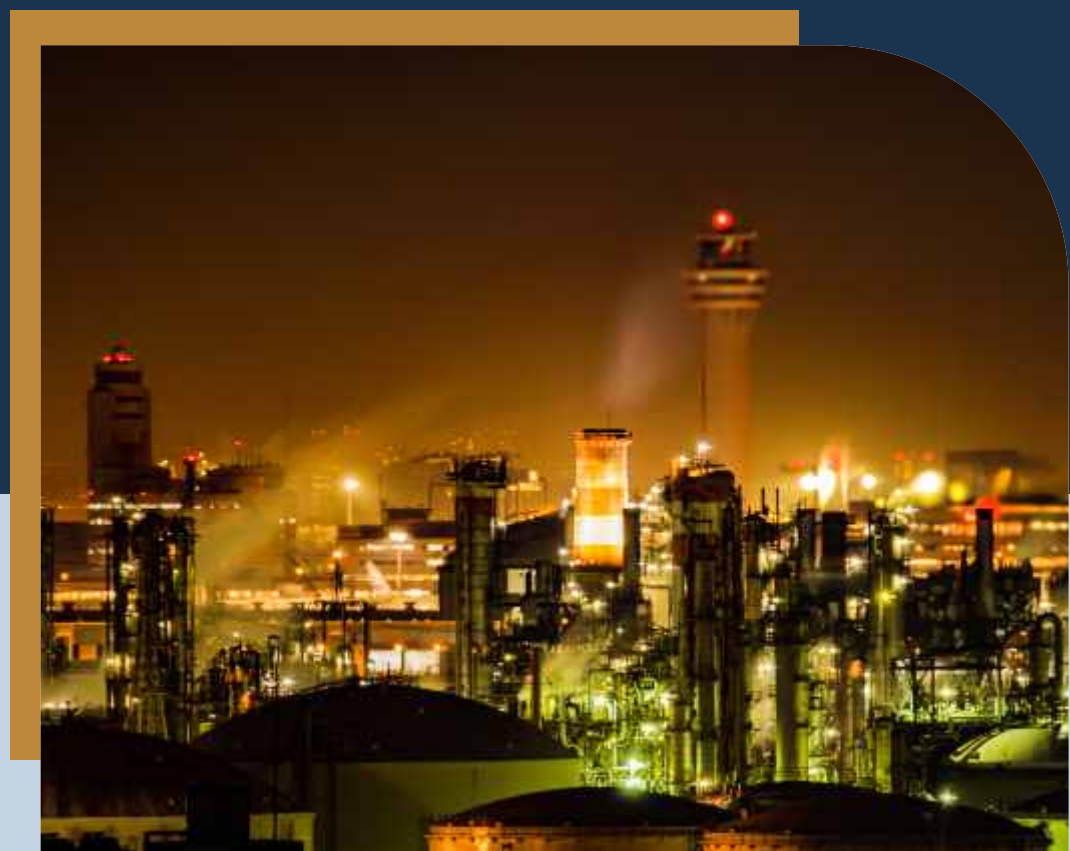

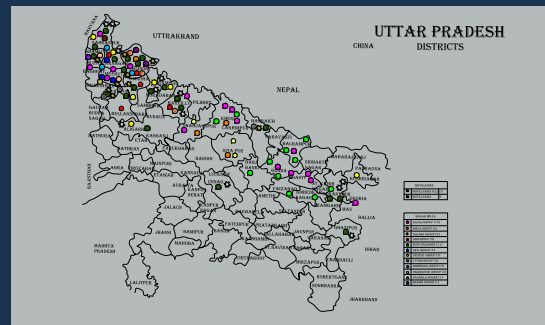
On, it has been year of challenges for the world, Nation and for the Industry owing to the Pandemic.

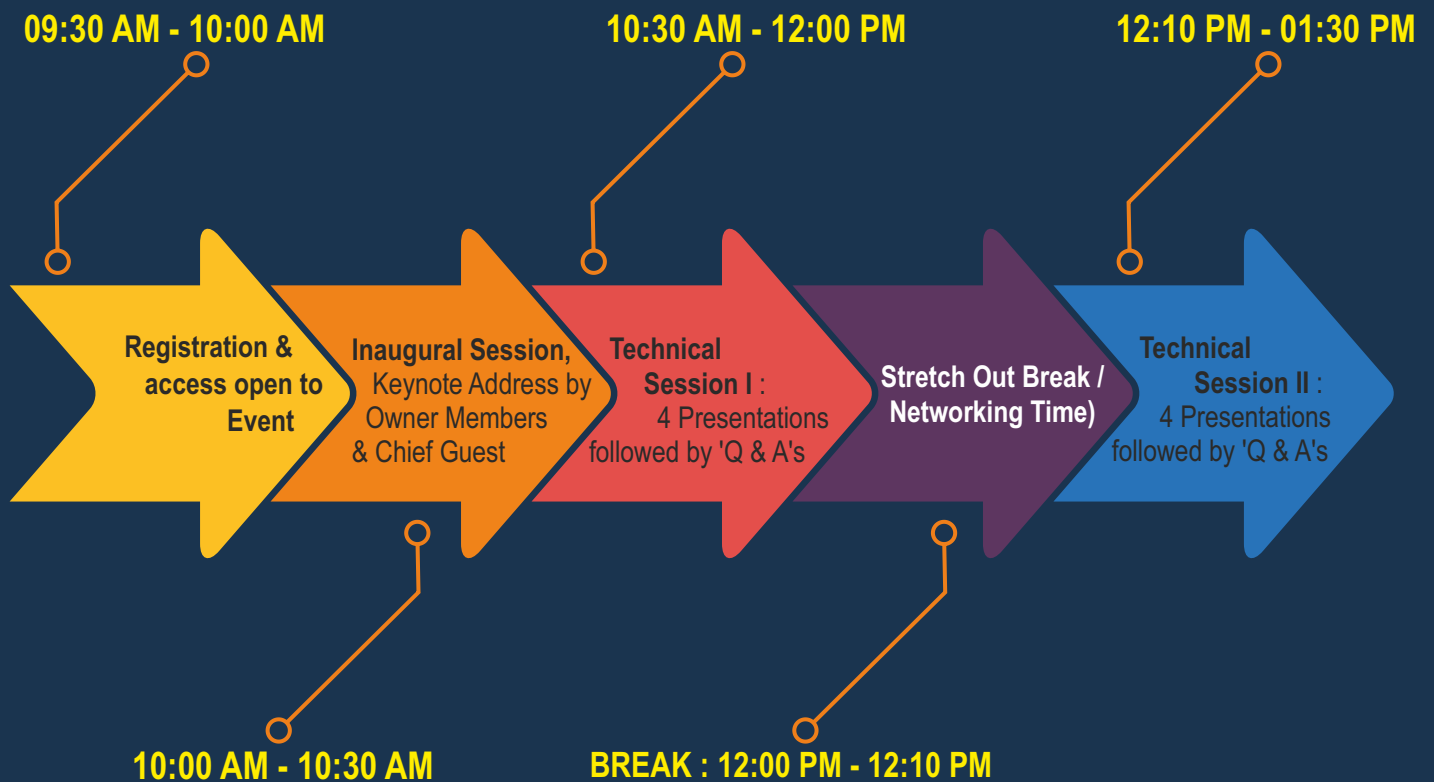
